**5. Essential Qualifications:-**

- Should be a Nambudri Brahmin, not being a Choli Brahmin or priestly class.
- Of pure descent and respectable family and possesses sufficient knowledge of Sanskrit and pujas & Tantra puja.
- Has an unblemished character and leads a celibate life.
- Professes the Hindu religion, accepts the form of worship practiced at the Temple, and is well-versed in the form of worship usually performed in the Hindu temples of Lord Vishnu.

**6. Educational Qualification:-** Must be literate.

**7. Preferential Qualification:-** Applicant having knowledge of Hindi & English Language will be given preference for appointment in service.

**8. Procedure for Submitting Certificates:-**

- a) The applicant will have to submit an affidavit, duly Notarized by a Notary, stating that applicant belongs to Nambudri family/descent and he had no criminal antecedents and not punished for any crime by court of Law.
- b) The applicant will have to submit an affidavit, duly Notarized by a Notary, for the truth and authenticity of all the certificates enclosed in the application. If the

certificates submitted by the applicant are found to be incorrect/false, the appointment/candidature of the applicant will be automatically cancelled/rejected.

c) The applicant will have to submit a Character Certificate issued by a competent authority.

**9. Performance of worship:-** The Rawal shall lead a celibate life and observe all the customary rites and usages in the matter of pooja under the direction of the Committee and shall perform such other duties relating to the worship of the Temple as may be laid down by the Committee from time to time.

**10. Probation:-** As per the provisions mentioned in Shri Badrinath Kedarnath Temples Act, 1939. The period of probation is being fixed by the Appointing Authority of BKTC, after the approval of Committee.

**11. Appointment:-** Appointment procedure/rules shall be prescribed by the Selection Committee constituted by the Appointing Authority of BKTC, according to the relevant section/rule/prescribed provision of the Act.
